Temporary Contract Permit Residential permit for contractors (especially those with commercial vehicles) doing work on a dwelling unit in a RPP area. This permit is good for up to 90 days or the length of the contract, whichever comes first. If the permit is needed for over 90 days, you will need to purchase the pass again. This permit is good Monday through Friday, 8:00 a.m. until 4:00 p.m.	Parking Locations: Area 5 - Ridgely's Delight	\$20.00	+ Add
Temporary Medical Child Care Permit This is an annual residential parking permit for professional or non-professional care providers with a notarized letter from the homeowner stating the days and times needed for care. The care provider must also show a valid vehicle registration.	Parking Locations: Area 5 - Ridgely's Delight	\$20.00	+ Add
Temporary Residential Permit This is available while resident finishes providing all required documents. It is valid for no more than 60 days.	Parking Locations: Area 5 - Ridgely's Delight	\$20.00	+ Add

Dual Residency


Please Note: Maryland Law prohibits local authorities from issuing an RPP permit valid for more than 60 days to any vehicle registered outside of Maryland, unless the owner of the vehicle has obtained a Maryland MVA Nonresident Permit. A copy of the processed MVA Nonresident Permit application (form VR-111) must be presented to the Parking Authority of Baltimore City (PABC) to obtain an RPP permit that is valid for more than 30 days. A Nonresident Permit must be presented along with any other required documentation. For MVA Nonresident Permit application information please contact the MVA office at (800) 950-1682.
